**Entry Information:** All entries must be submitted on an official CFA entry form, printed or typed clearly.

All checks must be drawn on US banks and in US funds. Please make checks payable to Hawkeye State Cat Club.

No fee will be returned for failure to bench. Per show rule 11.08.a faxed and email entries MUST be paid within ten days of receipt or prior to the start of the show, whichever is first.

Only ONE benching request will be honored. **All Security cages** require a extra 1/2 cage space: \$20.00 1/2 cage fee applies.

*Wire benching cages will not be set-up, but will be available for exhibitors use.*

**Benching Information:** Check-in between 8:30 – 9:30 Saturday

Judging will begin at 10:00 AM on Saturday and 9:00 AM on Sunday

Advertised hours: 10 - 5 Saturday: 9 – 3 Sunday

This is a non-vetted show. Cats are expected to be free of fungus, fleas and infectious disease. Exhibitors are advised to have their cats vaccinated against Feline Enteritis, Rhinotracheitis, and Calici Virus. FELV testing is recommended. All claws must be clipped, front and back. Cats are not allowed to remain in the show hall overnight. No smoking is permitted in the benching areas. Litter will be provided, please bring your own litter pans, food, dishes and cage curtains. Single cage sizes are 21"X21"X21". Double cage size is 21"X21"X45". No more than one cat or two kittens may be benched in a single cage. Only cats entered in the show or for sale may be present in the show hall. Hawkeye State Cat Club will take reasonable care to safeguard the property of exhibitors. Neither the club, its members nor Adventureland will be liable for any loss or damage. If the management of Adventureland decides that no cars can be parked "in back", you may be asked to move your vehicle once it is unloaded. This show hall is handicapped accessible. Food will be available.

**CFA Info:** All Championship, Premiership and Registered kitten entries will be scored for CFA Regional/National awards. All AOV, Provisional, and Miscellaneous entries must have a CFA registration number. This show is licensed by The Cat Fanciers Association, Inc. All CFA rules will be enforced. The show rules may be purchased from CFA for \$5.00 by writing to: CFA, 1805 Atlantic Ave., PO BOX 1005, Manassquan, NH 08736. Ribbons and Rosettes will be offered in all rings as required by CFA Show Rules. CFA approved Permanent Flats will be used.

According to Iowa law, smoking is no longer permitted in public buildings. Adventureland will determine smoking area.

**DRIVING DIRECTIONS:**

**To get to the Back Entrance(s) of the Show Hall, take the Service Entrance on 34th Ave NW at the base of the Roller Coaster.**

**From the East – I-80.**

Take first Des Moines Exit 142. Turn Left on Highway 65/69 –Hubbell Ave. You are now going SW. Go through major intersection. Turn left at next corner-34th Ave, NW, (There is now a Stop Light—Same street, they just changed the name.) Service Entrance is on the Left hand side at base of the roller coaster.

**From West – I-80.**

Take exit 141 **Immediately** exit on Hubbell Ave –Exit 83 Turn left on Hubbell(Highway 65/69). Turn Right on 34th Ave.. NW. (There is now a Stop Light—Same street, they just changed the name.) Service entrance is on the Left at the base of the Roller Coaster.

**From North.** I-35 to I-80. Follow West Directions

**From South,** I-35 to I-80. Follow West Directions. **Or** from I-35 take Exit 68 (Hwy 5) which connects w/ Hwy 65/69 This goes around the South side of Des Moines, Take Exit #83 – Hubbell Exit. Go through first stop light. Turn Right on Hubbell. Then Right on 34th Ave NW. Service entrance is at the base of the Roller Coaster.
