Hotels: There is no designated show hotel. For a list of available hotels, please refer to the show website.

Household Pets: Will be judged in all 6 rings. Household Pets (HHP) must be over 4 months of age and spayed or neutered prior to 8 months of age. Declawed cats are NOT eligible for entry.

Entry Information: All entries must be submitted on an official CFA entry form, printed or typed clearly. On-line entry is available at www.cfamidwest.org All fees must accompany entries. Please make checks payable to **Sandhills Cat Club**. No fee will be returned for failure to bench. Per show rule 11.08.a faxed and email entries MUST be paid within ten days of receipt or prior to the start of the show, whichever is first. One half cage is included with each entry. All Security cages require a double cage space: \$20.00 double cage fee applies. Wire benching cages will not be set-up, but will be available for exhibitors use.

Show Hours: Exhibitor Check-in Saturday 7:30 am - 8:30 am
Judging Saturday 9:00 am - 5:00 pm or until finals are completed
Advertised hours are Saturday 9:00 am – 4:00 pm

There will be NO SMOKING in the show hall.

This is a non-vetted show. Cats are expected to be free of fungus and infectious disease. Exhibitors are advised to have their cats vaccinated against Feline Enteritis, Rhinotracheitis, Calici Virus, and Rabies. FELV testing is recommended. All claws must be clipped prior to benching. No kitten under 4 months of age will be allowed in the show hall. Owners of very small kittens may be asked to show registration papers. An exhibitor must own cats and kittens for sale. Minimum sales price is \$100.00 and it is strongly recommended that all pet sales have a spay/neuter agreement. Litter will be provided, please bring your own litter pans, food, dishes and cage curtains. Single cage sizes are 21"x21"x21". Double cage size is 21"x21"x45". No more than one cat or two kittens may be benched in a single cage. Only cats entered in the show or for sale may be present in the show hall. Reasonable care will be taken to safeguard the property of the exhibitors; however, neither Sandhills Cat Club nor Seward County Agricultural Society will be liable for any loss of damage.

Sandhills Cat Club reserves the right to add judges not named to judge non-championship and non-premiership classes.

CFA Information: All Championship, Premiership and registered Kitten entries will be scored for CFA Regional/National awards. All AAOV, Provisional, and Miscellaneous entries must have a CFA registration number. This show is licensed by The Cat Fanciers Association, Inc. All CFA show rules will be enforced. To obtain a copy of the show rules, send \$5.00 to CFA, 1805 Atlantic Ave., Manasquan, NJ 08736-1005. Ribbons and Rosettes will be awarded in all rings as required by CFA Show Rules. Permanent flats will be used. Ribbon flats will be available.
