Entry Info: All entries must be submitted on an official CFA entry form, printed or typed clearly. All checks must be drawn on US banks and in US funds. Please make checks payable to Tigers Lair Feline Fanciers. Only ONE benching request will be honored.

Benching Info: Check-in between 8-8:30 a.m. Judging 9 a.m. - finals. This is a non-vetted show hall. Cats are expected to be free of fungus, fleas, and infectious disease. Exhibitors are advised to have their cats vaccinated against Feline Enteritis, Rhinotracheitis, Calicivirus, & tested for FeLV prior to entry. All claws must be clipped, front and back. Cats are not allowed to remain in the show hall overnight. Hall provides heat/air as required. No smoking is not permitted in benching areas. Litter will be provided. Please bring your own litter pans. Cage sizes are 22" x 22" x 22". Parking is free.

For Sale: Limit one (1) sales cage per exhibitor. Kittens must be at least 4 months old. CFA litter registrations may be required by show management. There is a maximum of two kittens per single cage. POSITIVELY NO CATS OR KITTENS WILL BE ALLOWED IN CARRIERS UNDER TABLES.

Cat Info: All Championship, Premiership and registered kitten entries will be scored for CFA Regional and National awards. All CFA rules will be strictly enforced. These show rules may be purchased from CFA for \$5.00 by writing to: CFA, 1805 Atlantic Ave., PO Box 1005, Manasquan, NJ 08736-0805.
