SHOW HOURS:

Check-in time is 7:30-8:30. Show will begin at 9:00am. Advertised hours are 9:00am – 4:00 (Finals). All benched entries will Be expected to remain in the show hall until advertised closing time, unless permission is given by Show Manager

- 1) All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of novices can contact the entry clerk for a temporary registration number. Kittens may be entered without registration numbers but will not be scored for CFA awards if a number is not provided at show time. Kittens without a registration number or TRN will be included in the count.
- 2) Check your confirmation for accuracy! Please contact the entry clerk with any corrections BEFORE CLOSING DATE. No refunds after the entry clerk has confirmed your entry or for failure to bench." "Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online/fax entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first
- 3) No veterinarian inspection prior to benching will be required. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for Fe V before entry.
- 4) 5.01 e. All claws of all entries must be clipped prior to benching. Reasonable care will be taken of cats and personal property. Neither Frontier Feline Fanciers, nor its individual members, nor Johnson County Fair shall be liable Show hall is heated, ceiling fans available, no air condition –show hall is handicap accessible

SUPPLIES: Litter will be provided. Bring your own litter pans, cat food and water dishes. A single cage is provided with each entry. Single cage size is 21 x 21 x 21; double cage size is 21 x 21 x 45. Bring cage curtains or towels to hang on the inside, top and Bottom of cage.
