Payment Information

Please make checks payable to Illini Cat Club. Per
show rule 6.21, each entry must be accompanied by
the stipulated entry fee. All online entries must be
paid in full within 10 days of receipt or prior to the
start of the show. The use of the online entry form is
interpreted as an official entry in this CFA show and
your email address on the form is considered to be
your signature. There is a \$50 fee for any returned
checks. Payment not received by 3/3/2024, will incur
an additional \$50 late fee. Cash only at the door. We
will take Square for payment.



Transportation

Central Illinois Regional Airport
(BMI) is serviced by American
and Delta Airlines. Bloomington
is 2.5 hours from Ohare and 2
hours from Chicago Midway
(Southwest Air). The club is
unable to provide transportation
to and from the airports. Nearby
Peoria and Decatur have United
Service.

Miscellaneous: Show management will take reasonable care of cats and carriers but will not be responsible for damage or loss. This is a NON-SMOKING facility. Benching cage size is 22 x 22 x 22. Litter provided, bring your own pans.

Vetting: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All cats/kittens must have all claws clipped prior to benching. Declawed cats are not eligible for competition.

Scoring: All entries in Championship, Premiership, registered kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners cats not registered in CFA, contact the entry clerk at least 3 weeks before the show for information on competing with a TRN.

All federal, state, local and CFA mandatory COVID-19 restrictions will be observed. All attendees are expected to follow the CFA mandatory COVID-19 requirements and recommended general practices, local, county, state, national and event facility regulations.
